The Stewards, having received a report from the Race Director, have considered the following matter and determine the following:

Car No: 93 Driver: JONATHAN HUI

Facts:

- Crossed the white line at pit lane: entry  exit
- Exceeded the speed limit in the pit lane with a speed of 62 km/h
- Did not respect yellow flags  repeatedly
- Did not respect track limits  repeatedly
- Made a false start
- Caused a collision
- Forced a driver off the track
- Illegitimately impeded another driver during overtaking
- Pit lane infringement .....

- Breach of Article 25.8 of the 11th Gulf 12 Hours Race 2022 Sporting & Technical Regulations
- Breach of Article ..... of the FIA International Sporting Code
