The Stewards, having received a report from the Race Director, have considered the following matter and determine the following:

Car No: 91 Driver: Not applicable

Facts:

- Crossed the white line at pit lane: entry  exit
- Exceeded the speed limit in the pit lane with a speed of \_\_\_\_\_ km /h
- Did not respect yellow flags  repeatedly
- Did not respect track limits**  repeatedly
- Made a false start
- Caused a collision
- Forced a driver off the track
- Illegitimately impeded another driver during overtaking

- Breach of Article 8.15 of the 11th Gulf 12 Hours Race 2022 Sporting & Technical Regulations**
- Breach of Article 2 c) of the FIA International Sporting Code Appendix L Chapter IV**
