The Stewards, having received a report from the Race Director, have considered the following matter and determine the following:

Car No: 2 Driver: MIKA BAJU

**Facts:**

- Crossed the white line at pit lane: entry  exit
- Exceeded the speed limit in the pit lane with a speed of \_\_\_\_\_ km/h
- Did not respect yellow flags  repeatedly
- Did not respect track limits  repeatedly
- Made a false start
- Caused a collision
- Forced a driver off the track
- Illegitimately impeded another driver during overtaking
- Pit lane infringement .....

- Breach of Article 86/32.1 of the 12th Gulf 12 Hours Race 2023 Sporting & Technical Regulations
- Breach of Article 21 of the FIA International Sporting Code APP. 2 CHAP. IV

CAR 2 MADE CONTACT WITH THE REAR OF CAR 73, CAUSING CAR 73 TO STOP. THE STEWARDS RECEIVED THAT DRIVER 2 WAS SURPRISED BY HOW EARLY CAR 73 BRAKED BUT CONSIDER CAR 2 TO BE PREDOMINANTLY RESPONSIBLE FOR THE COLLISION AS THE OVERTAKING DRIVER.
